Montgomery County welcomes you to the public meeting. This public meeting is being conducted both virtually and in-person. Both options provide an opportunity to view a prerecorded presentation in English and Spanish and provide your feedback on the proposed project. The purpose of the public meeting is to present alternatives for consideration and gather input. Your participation is important in the project development process. Project Description

During this public meeting, you are invited to review materials for the proposed alternative improvements to FM 1486 from FM 1774 to Jackson Road, in Montgomery County. The proposed project would widen the existing 2-lane undivided roadway to a 4-lane roadway with a raised median, 10-foot-wide outside shoulders and would include bike and pedestrian accommodations within a proposed 220-foot-wide right-of-way (ROW). Drainage would be via roadside ditch.

There are three proposed build alternatives being presented that include the same roadway configuration and improvements. Alternative 1 proposes to take the additional ROW from the west side of FM 1486, Alternative 2 proposes to take the additional ROW from both sides of FM 1486, and Alternative 3 proposes to take the additional ROW from the east side of FM 1486. The preferred alternative would move forward into the next stage of project development, which consists of preliminary design and environmental analysis.

Why is this project proposed?

The proposed FM 1486 improvements are needed because the existing facility does not provide adequate mobility to accommodate projected traffic volumes. Additionally crash rates are higher than the statewide average along the proposed project corridor.

The purpose of the proposed project is to improve mobility and safety along the project corridor.



Existing Roadway

The image below represents a cross-section view of the roadway as it is today. Within the project limits, the existing right-of-way is typically 100 feet, although it varies between 91 and 190 feet. The existing roadway is a two-lane undivided facility with one 12-footwide travel lane in each direction and 4-foot-wide outside shoulders. Drainage is via roadside ditch.



Montgomery County commits to purposefully involve the public in planning and project implementation by providing for early, continuous, transparent and effective access to information and decision-making processes.

Proposed Roadway

The image below represents a cross-section view of how the road might look after construction of the proposed project. The proposed project would widen the existing roadway to a four-lane divided facility. Travel lanes would be 12 feet wide, with 10-foot-wide outside shoulders and 4-foot-wide inside shoulders. A 40-foot-wide raised median is also proposed. Additionally, the project includes a 10-foot-wide shared use path for bicycle and pedestrian use. Drainage would remain via roadside ditch. The proposed right-of-way is 220 feet.
